We would like to inform you about important legislative developments in the area of the **EUDR (EU Deforestation Regulation)**, which sets out requirements for the traceability and proof of non-deforestation origin of selected commodities and wood products.

Approved amendments to the EUDR – exclusion of CN 49 from the scope

As part of the discussion of the so-called **omnibus package**, amendments to the EUDR were approved, which, among other things, change the scope of regulated products.

One of the key changes is the **exclusion of printed products falling under customs nomenclature CN 49 from the scope of the EUDR**.

This means that printed products are **no longer subject to due diligence obligations** under this regulation and do not need to be recorded in EUDR systems (e.g., geolocation of original land or proof of non-deforestation origin of the commodity).

Summary of the EUDR's development to date

- The EUDR was adopted in 2023 with the aim of reducing global deforestation and increasing the transparency of supply chains.
- The original text also included paper and printed products as part of wood commodities.
- Following intensive discussions at the level of Member States, industry representatives, and the European Commission, it was assessed that the printing and publishing sector is not a relevant source of deforestation risk.
- In 2025, it was therefore **finally approved** that **printed products (CN 49)** would be **excluded** from the scope of the regulation.

EDS Group's position

Although printed products are no longer covered by the EUDR, we want to assure you that **EDS Group GmbH's** approach to responsible resource management remains unchanged.

We have been implementing responsible practices for a long time:

- we regularly check the **origin of the wood** in the paper we purchase,
- we require all suppliers to provide a **declaration of the legal and ethical origin of the wood**,
- most of the materials we use come from sources certified by the **FSC®** and **PEFC™** standards,
- and we maintain a high level of transparency across the supply chain.
